

# New Zealand mobility parking permit application form for overseas visitors



## What is the mobility parking permit

Mobility Parking Permits allow people to use:

- Accessible car parks [displaying the wheelchair symbol]
- Standard car parks and metered spaces for longer than stated times, and
- Many time restricted zones, e.g. P30 for longer than stated times (as set out in local bylaws)

Concessions can vary so please check the current provisions for the area you will be in with the local council.

## Your responsibilities

There are some responsibilities and rules you need to follow when using your mobility parking permit.

- 1. Display your permit clearly**  
Your permit must be displayed on the dashboard, with the details clearly visible from the outside of the vehicle.
- 2. Your permit can only be used by you**  
The permit is issued to you, and a unique number and barcode is printed on it. Your permit cannot be used by another person.
- 3. Only use your permit if you need to get in or out of the vehicle**  
If you, the permit holder, are staying in the vehicle, you must park in a standard parking space (not a designated mobility parking space), and the permit cannot be displayed.

Permits no longer required by the permit holder need to be returned to CCS Disability Action.

## How much does a short term permit cost?

Overseas visitor permit  
(can be issued for up to  
12 months)  
**NZ\$35.00 - GST inclusive**

Please note: An overseas visitor permit can be extended to a maximum of 12 months from the date of issue, for an additional NZ\$5.00.  
**Sending to an overseas address will cost an extra NZ\$10.00.**

## Eligibility criteria?

Having a medical condition or disability does not automatically entitle you to a mobility parking permit. You are eligible if you meet the following criteria:

- 1.** You are unable to walk and always require the use of a wheelchair, or
- 2.** Your ability to walk distances is severely restricted by a medical condition or disability.  
If for example, you require the use of mobility aids, experience severe pain, or breathlessness.
- 3.** You have a medical condition or disability that requires you to have physical contact or close supervision to safely get around and cannot be left unattended. For example, if you experience disorientation, confusion, or severe anxiety condition.
